It has now been decided that the special dispensation would continue to be exercised in deserving cases by the Commissioner with the prior approval of the Chairman. However the entire issue is being reviewed once again before the commencement of the next academic session.

The other references are to routine administrative matters. The Government is always willing to discuss matters with Kendriya Vidyalaya Sangathan employees' Associations with a view to looking into their genuine grievances so that appropriate solutions could be arrived at. The Chairman of the Kendriya Vidyalaya Sangathan has recently held meetings with different associations representing Kendriya Vidyalaya Sangathan employees to examine their grievances.
