### **Covering BPL families in Gujarat under PDS**

2651. SHRI AHMED PATEL : Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

(a) whether Government have identified the BPL families in Gujarat to be covered under the targeted PDS:

(b) if so, the details thereof.

(c) whether all of them have been given special ration cards; and

(d) if not, the reasons therefor ?

THE MINISTER OF STATE ON THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI ASHOKPRADHAN): (a) to (d) As per the report received from the State Government, the Government of Gujarat

[13 December.2001) - RAJYASABHA

has identified 33.93 lakh BPL families under the Targetted Public Distribution System. The poverty estimates of the Planning Commission for the year 1993-94 on the population projections of the Registrar General as on 1-3-2000 for the State of Gujarat is 21.20 lakh families. All the identified BPL families have been issued BPL ration cards.

(a) and (b) A statement giving details of the total number pf buildings taken on rent along with total expenditure incurred thereon during the years 1998-1999 to 2000-2001, country-wise, is enclosed, (*see below*)'. This information in a summarized table is given below.

(c) Requests have been made by the Government of India for plots of land in Ethiopia. Kazakhstan. Russia. Tanzania. Turkmenistan. Vietnam and Yugoslavia. The Government has already acquired plots of land in Bangladesh. Botswana. Brazil. Cliina. Mauritius, Nepal. Nigeria. Oman, Pakistan. Poland. Qatar. Russia, Tanzania, Trinidad & Tabago and Uzbekistan for construction of Embassy buildings. As far as purchase of built-up properties is concerned, properties have been identified in Tehran (Iran) and Damascus (Syria) for purchase of Ambassador's Residence and Chancery's premises, respectively. Proposals for purchase of Permanent Representatives residence in New York, Consul General's residence in Chicago and Cultural Centre in Washington are currently under preliminary examination.
