The main project activities are plantations, sand dune stabilisation pasture, development, farm forestry, etc. Japan is not assisting any afforestation project in Haryana.

(b) and (c) The Bihar Social Forestry Project is being implemented in the Chhota Nagpur and Santhal Pargana areas with the assistance provided by the Swedish International Development Authority (SIDA). The project was started in 1985-86 and will close in March, 1992. As against the original project cost of Rs. 53.85 crores, the expenditure ending March, 1991 was Rs. 42.01 crores:
