Adequate number of purchase centres have opened by FCI in consultation with State Governments.

(b) State-wise details of wheat, rice and paddy procured by the Food Corporation of India including state agencies during the last four years can be seen in the statement I to V (*see* below)

(c) In order to reduce the buffer carrying cost of buffer stock and storage, Government has initiated the following steps to liquidate the stocks:—

- (i) Increase in the allocation of foodgrains to 25 kg. per family per month under BPL.
- (ii) Reduction in Central Issue Prices w.e.f. 25.7.2000 and further reduction in APL prices by 30% w.e.f. July, 2001.
- (iii) To offer wheat and rice at prices lower than the economic cost under open sale.
- (iv) Issues under various welfare schemes like MDM, Nutrition Programme, Food for Work, Annapooma and for indigent people (destitute women and children), SC/ST and OBC hostels etc. at BPL prices, instead of at economic price.
- (v) Wheat and rice are being issued to the identified poorest of the poor families @ Rs. 21- and Rs. 31- per kg. respectively, under Antyodaya Anna Yojana Scheme.
- (vi) Export of wheat and rice at prices lower than the economic cost.
- (vii) Wheat and rice is also being issued under 'Sampooma Gramin Rojgar Yojana' in the States of Chhattisgarh, Haryana, Punjab and Uttar Pradesh sponsored by the Ministry of Rural Development.

With these steps the average monthly off-take of foodgrains has gone up from 14.96 lakh tonnes during 2000-2001 to 19.34 lakh tonnes during 2001-2002.
