Import of timber and pulp

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH): 60 and (b) Import of timber and pulp is under Open General Licence (OGL) and information on import of these items is available with the Government upto the year 1988-89 only. The details for the years 1986-87, 1987-88 and 1988-89 are given in the statement annexed. (See below)

(c) The import of timber and pulp is currently under OGL.
