THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI TAPAN SIKDAR): (a) No Sir, the Government has plan to provide a public telephone in all villages of the country by the year 2002. Once all the villages are covered in the country. Panchayats will also be covered as it is included in all villages.

- (b) The information is given in Statement-I (see below)
- (c) For better telephone facility to village panchayats the Govt, has started inducting new technologies like C DOT, TDMA/PMP and Wireless in Local Loop (WLL) systems into rural telephony. No target has been set for village panchayats. However, the target is for covering 6.07,491 villages with a public telephone during the year 2002 and budgetary allotment is Rs. 811.52 crores (Statement-II) by BSNL fortheyear2001-02.
