## Conspiracy to assassinate Rajiv Gandhi

1964. SHRI MURLIDHAR CHAND-RAKANT BHANDARE: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government's attention has been drawn to the reports from Sri Lanka to the effect that the conspiracy to assassinate the former Prime Minister Shri Rajiv Gandhi was carried out under direct supervision and guidance of the LTTE Chief; and
- (b) if so, what is Government's reaction thereto, especially with regard of the identification and deportation of LTTE elements from the country?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI M. M. JACOB): (a) Such reports have come to the notice of the Government.

(b) The issue of conspirary to assassinate the former Prime Minister Shri Rajiv Gandhi, with all its remifications, has been referred to a commission of inquiry headed by Shri Justice M. C. Jain. It is, therefore, not considered in public Interest to disclose the Government's stand on this issue.

#### Corruption in Delhi Police

- (a) whether it is a fact that the average standard of living of officers from a constable upwards in Delhi Police is disproporationately more than his known sources of income:
- (b) if so, whether Government propose to institute a probe in the matter with a view to determine the magnitude of corruption in Delhi Police; and
- (c) if not, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AF-FAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AF-FAIRS (SHRI M. M. JACOB): (a) to (c) The Delhi Police have reported that it is not correct to states that the average standard of living of officers from Constable upward in Delhi is disproportionately more than their known source of income. Whenever any such instance come to notice, an inquiry is made. The Delhi Police have further reported that from 1st January, 1989 to 31st October. 1991, 121 Police Officials were punished on corruption charges.

Sunday dated the 10th November, 1991 regarding collection of sweet boxes by a PCR van manned by Police Officials;

- (c) what action Government propose to take to investigate the incident in particular and the corruption among the Delini Police in general?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY **AFFAIRS** AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI M. M. JACOB): (a) to (c) A new item appeared in the "Times of India" in its issue of 10th November, 1991 mentioning that a PCR (Gypsy) on duty in Vasant Kunj halted at every sweet shop and collected a one km, box of sweet from each shop on the occasion of Diwali. Delhi Police has reported that an inquiry was conducted into the matter by senior officers. The shopkeepers were also contacted but there was no collaboration from any shopkeeper. The Delhi Police have further reported that it is not correct to state that Corruption at all levels of Delini Police has become the order of the day. Whenever any complaint is received an inquiry is made.

### Extortion of Money from Pavement Vendors

- (a) whether it is a fact that the officers of Delhi Police particularly those belonging to Central District are regularly extorting money from pavement vendors in their areas;
- (b) whether it is also a fact that the booty is collected regularly by the beat constables including the considerations in kind and distributed among the entire chain of officers; and

(c) if so, whether Government propose to institute a CB1 probe against all the officers of the Central District in Delhi with a view to check the corruption?

THE MINISTER OF STATE MINISTRY IN THE OF PARLIAMENTARY **AFFAIRS** AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI M. M. JACOB): (a) to (c) The Delhi Police have reported that during the year 1990 and 1989. two complaints received against the officials belonging to Central District alleging harassment to the patriwalas and demanding of money by police officials from them. On completion of inquiry into one of the complaints 5 police officials were transferred to nonsensitive posts and regular departmental proceedings initiated against them. An inquiry has been initiated by the Vigilance Branch into the second complaint. There is no proposal to institute a CBI probeagainst all the officials of the Central District in Delhi.

# Problem of Drunkenness among: Delhi Police
