श्चना और प्रसारण मंत्रालय में उप मंद्री (कुमारी गिरिजा व्यास): (क) ग्रौर (ख) जी, हां, दोनों सदनों के पीठासीन अधिकारियों ने इसका अनुमोदन कर दिया है । तदनुसार, दूरदर्शन ने प्रायोगिक तौर पर 3 दिसम्बर, 1991 से संसद की कार्यवाही का प्रसारण, श्रार्म्भ कर दिया है। दोनों सदनों के प्रश्न काल की रिकार्डिंग ग्रगल दिन प्रसारित करना योजना में शामिल है । दोनों सदनों को साप्ता-हिक श्राधार पर बारो-बारो से कबर किया जाता है।

T.V. Serial proposals pending for clearance

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) and (b) According to Doordarshan, 3545 proposals for sponsored T. V serials for telecast on the national network received against their invitation of October, 1990 are pending clearance. All these are under various stages of evaluation.

Transmission of Indian programmes abroad

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) to (c) Reception of foreign TV programmes through satellites is available in various parts of the country through Dish Antenna. However, there is no discernible evidence of any adverse impact on Doordarshans viewership. ments have been made for the reception of Doordarshan programmes outside India in the neighbouring countries with a dish antenna. Discussion and study are continuing to further extend the area of transmission of Indian programmes.
