लिए रा.शै.ग्र.प. द्वारा स्यापित उच्चाधिकार प्राप्त तकनीकी खरीद समिति निश्चित की जाती है । सिर्फ कुछ ही फर्मों के पास सोफ्टवेयर पैकेज हैं जो संभिति द्वारा ग्रनिवार्य समझे जाने वाली विनिर्देशनों को पूरा करती है । उपलब्ध पैकेज ज्यादातर स्वामित्व वस्तुएं हैं जिनकी त्लना नहीं की जा सकती । ग्रतः एक ही निविदा को स्वीकार करना भ्रपरिहार्य है। फ्लोपी मीडिया पर ग्रायात बंधनों के कारण, रा.में.ग्र.प्र.प.की फ्लोपी की लागत सहित सोफ्टवैयर की खरीद विके-ताम्रों से करनी पड़ती है । ब्रिटिश सोफ्ट-वेयर सिर्फ उन्हीं फर्मों से स्वीकार किया जाता था जिनके पास ब्रिटेन में मालिकों के साथ समझीता के ग्रधीन इनका उत्पादन करने का लाइसेंस रखते हैं।

- (9) पैकेजों की श्रापूर्ति में एकरूपता की कमी परियोजना के कार्यान्वयन के बाद के वर्षों के दौरान सभी श्रायात किए गए पैकेजों की श्रनुपलब्बता के कारण थी। अब, जबिक कार्यक्रम को देशी रूप से विकसित सोफ्टवेयर तथा उपलब्ध श्रायात किए गए सोफ्टवेयर पर निर्भर करना है, सोफ्टवेयर की श्रापूर्ति में एक-रूपता को बनाए रखना सम्भव होगा।
- (10) संडाधन केन्द्रों की संख्या जे! मूलतया 42 थी बढ़कर 60 हो गई है। संसाधन प्रतिबंधों के कारण, संसाधन केन्द्रों के नेटवर्क का बड़े पैमाने पर विस्तार सम्भव नहीं हुआ है।

## Preservation of Sites of Archaeological Importance in Madhya Pradesh

- 2392. SHRI SURESH PACHOURI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:
- (a) whether it is a fact that a number of sites of Archaeological importance have recently been found in the State of Madhya Pradesh;
- (b) if so, what are the details in this regard;
- (c) whether it is also a fact that many of such sites were already damaged by local people before the Archaeological Department stepped in;
- (d) if so, to what extent the sites were damaged; and
- (e) what action Government propose to take preserve the sites of Archaeological importance being found in the country?

HUMAN MINISTER OF THE RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) Yes, Sir. Sites of archaeological importance showing mierolithic, neolothic, and early megalithic historical association including rock shelters with or without paintings have been recently discovered Madhya in Pradesh.

- (c) and (d) Some Megalithic sites at villages Aroud, Bhawarmara and Lilar. District Raipur and at village Tengna, District Durg have been damaged due to quarrying and blasting for road making.
- (e) The concerned authorities have been requested to take immediate preservative measures.

## **Publication of Books**

- MINISTER OF HUMAN THE RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) The publishes school textbooks for classes I-XII mainly for the students of CBSE-affiliated schools, through private printers on the approved schedule of rates. The State Governments have their own arrangement for publication and printing of school text-books for the students of schools affiliated to the respective State Boards. According to the UGC, for college prepared by Universities, the State Grant Academics and private lishers.
