THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) Yes, Sir. The AIKVTA has suggested for appointment of a new Commission on School Teachers. It has also been demanded that some representatives

of teachers should be nominated as members of the Commission.

(c) Central Government has appointed two National Commissions on Teachers in February, 1983—one dealing with teachers at the school stage and the other for teachers at the higher education level (including Technical education). The reports of these Commissions were received in 1985. The Reports of these Commissions have duly been considered by Government. THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) It is a fact in the case of promotion to the levels of

Post Graduate Teacher and above. However, this does not apply to teachers and officers who are due to retire within three years.

(b) No Sir, but it is the normal rule.

(c) In the case of personnel going on promotion as referred to in the answer to part (a) above:

1990-91 1 Post Graduate Teacher

1991-92 4 Post Graduate Teachers

and 2 Principals.

Publication of Books

2395. SHRI SANTOSH BAGRODIA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) what is the normal procedure for publication of books for schools and colleges by Government and whether they are printed directly by Government or through the private printing contractors; and

(b) whether it is a fact that there is a considerable delay in supply of such books and if so; what are the reasons therefor and in what manner Government propose to overcome this problem?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) The NCERT publishes school textbooks for classes I—XII mainly for the students of CBSE-affiliated schools, through private printers on the approved schedule of rates. The State Governments have their own arrangement for publication and printing of school textbooks for the students of schools affiliated to the respective State Boards. According to the UGC, for college prepared by the Universities, State Grant Academics and private publishers.

(b) According to the information received from the NCERT, its textbooks for all the classes I to XII for the academic session 1991-92 were made available to students in time. NCERT has not been facing any problem in getting its textbooks printed

through private printers. The sale and distribution of NCERT textbooks are done through 35 Wholesale Agents located all over the country. In order to improve the delivery system of its textbooks, NCERT has decided to open regional publication and distribution centres at Calcutta, Madras and Ahmedabad. The State Governments are competent to deal with the situation arising out of delay in publication and distribution of school and college textbooks for the students of educational institutions under their control.
