- MINISTER OF HUMAN THE RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) The publishes school textbooks for classes I-XII mainly for the students of CBSE-affiliated schools, through private printers on the approved schedule of rates. The State Governments have their own arrangement for publication and printing of school text-books for the students of schools affiliated to the respective State Boards. According to the UGC, for college prepared by Universities, the State Grant Academics and private lishers.
- (b) According to the information received from the NCERT, its textbooks for all the classes I to XII for the academic session 1991-92 made available to students in NCERT has not been facing any problem in getting its textbooks printed

.hrough private printers. The sale and distribution of NCERT textbooks are done through 35 Wholesale Agents located all over the country. In order to improve the delivery system of its textbooks, NCERT has decided to open regional publication and distribution centres at Calcutta, Madras and Ahmedabad. The State Governments are competent to deal with the situation arising out of delay in publication and distribution of school and college textbooks for the students of educational institutions control.
