Times the Hindustan appeared in dated 2nd December, 1991 to the effect that the academicians, Social Scientists and media experts who met in a session entitled "Education and Social Tensions" have opined that the higher education in the colleges and Universities is in a 'State of Shambles":

- (b) if so, what are the details thereof; and
- (c) the steps Government propose to take in the matter?

MINISTER OF HUMAN-RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) Government is aware of the newspaper report appearing in Hindustan Times dated 2nd December, 1991 regarding deliberations of a 3-day convention organised by the National Media Centre. Government has, however, not received any proceedings of the convention from its organisers.

- (b) The following main points have been made in the newspaper report:—
  - —delinking of degrees from jobs.
  - -monitoring performance of academic community.
  - -use of Electronic media in support of education.
  - -appointment of an Education Commission.
  - -greater emphasis on use of English in higher education.
- (c) Most of the above suggestions were considered at the time of formulation of National Policy on Education —1986 and the following important steps have already taken in this regard:
  - National Evaluation Organisation has recently been set up with the main objective of conducting tests for those jobs which need not require a University degree.
  - -UGC has circulated to all Universities a model code of ethics and guidelines for performance praisal of teachers.

-UGC and IGNOU are telecasting educational programmes on national network of Doordarshan.

to Questions

As regards greater emphasis in the teaching and learning of English in institutions of Higher Education, the National Policy on Education 1968 and 1986 emphasised adoption of regional languages as the medium of instruction at the University stage, and provision of facilities for the study of English and other foreign languages.

Government had appointed a Committee to review the NPE-1986 under the Chairmanship of Acharya Ramamurti in May, 1990 and the Committee submitted a detailed report in December, 1990 covering all aspects of education. It is, therefore, not considered advisable to appoint another Commission on Education.

# Damage to Shravanabelgola due to **Illegal Mining**

2364. SHRI MOTURU HANUMAN-THA RAO: Will the Minister of HUMAN RESOURCE DEVELOP-MENT<sup>1</sup> be pleased to state:

- (a) whether Government's attention has been drawn to the news item which appeared in the Telegraph dated 23rd September, 1991 regarding damage to the 1000 year old monolith in Shravanabelgola (Karnataka) due to illegal mining in the area;
  - (b) if so, the details thereof; and
- (c) the steps being taken in this regard?

MINISTER HUMAN THE OF RESOURCE DEVELOPMENT ARJUN SINGH): (a) and (b) Yes, Sir. The news item states that the monolithic statue of Gomateswara is cracking due to buffeting by winds and rattling caused by unauthorised mining near by.

(c) Since 1978 the State Government has banned granting of mining lease within a radius of 2 Km. around the monument and it is reported that no quarrying operations are taking place in the vicinity of this monument now.

The crack noticed, in the statue has already been fllletted and chemically preserved by the experts of the Archaeological Survey of India.

(b) and (c) There is no system of allotting Kendriya Vidyalayas on district-wise or State-wise basis. The opening of new Kendriya Vidyalayas depends upon the suitability of the proposals from the prescribed user agencies, especially presence of a cluster of employees of the Central Government/Central Government Undertakings, availability of physical facilities and financial resources and administrative considerations.
