THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) Transfers are generally made as per the guidelines approved by the Board of Governors of the Sangathan which explicitly provide for transfer on administrative grounds as first priority vide para 6 of the transfer guidelines. Further more under para 14 of these guidelines, the Commissioner is competent to make such departures from the guidelines as he may consider necessary in the interest of the Sangathan.

The Chairman, being a superior authority, is generally competent to subordinate exercise the powers of functionaries in administrative matters.
