Scholarship to Students of Hilly Areas for higher education

2342. SHRI RATNA BAHADUR RAI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether there is any provision for grant of scholarship to students of hilly areas for higher education; and
 - (b) if so, the details thereof?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) The Ministry of Human Resource Development has no separate provision for grant of scholarships to students of hilly areas but they are considered alongwith others under existing schemes.

Non-Payment of Salary to Teachers under D. M. C.

2343. SHRI N. E. BALARAM: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether Government are aware that in some schools under Delhi Municipal Corporation, teachers were not paid their pay for October even upto 23rd November, 1991;
- (b) whether it is a fact that bonus and arrears of D.A. have also not Neen paid till date; and

(c) if so, the reasons therefor and the steps being taken to ensure that payment is made to them every month?

THE MINISTER OP HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) Yes, Sir.

(c) According to the information furnished by MCD, in some schools teachers could not be paid their salaries of October, 1991 upto 23-11-91 due to shortage of funds in some Zonal offices and non-compliance of certain formalities by some teachere.

Regular meetings are held with the Finance Department of M.C.D. to provide adequate funds at Zonal levels for making payment of salary and other dues to the teachers by 7th of every month. Zonal Officers have also been instructed to ensure timely payment to teachers.

Transfers of Teachers of Port Blair

- 2344. SHRI SAMAR MUKHERJEE: Will the Minister of HUMAN RE-SOURCE DEVELOPMENT be pleased to state;
- (a) whether it is a fact that a number of Teachers of Kendriya Vidyalaya, Port Blair are awaiting transfer to mainland, having completed their tenure in the Islands 'since long;

- (b) whether any steps are being taken to expedite their transfers; and
 - (c) if so, the details thereof?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (c) Thirty teachers have completed the normal period of stay at Kendriya Vidyalaya, Port Blair. Nine Teachers are not interested in transfer to the mainland. Transfer orders of 16 teachers have been issued. The remaining 5 teachers have been retained for the time being until substitutes are posted.

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI ARJUN SINGH); (a) and (b) pass in the Final|Direct Final Examination of the Institute of Surveyors Building and Quantity Surveying has been recognised by the Government of India for the purpose of employment under the Central Government in the appropriate field Prescribing qualifications for employment and promotions under State Services is the prerogative of the concerned State Governments

Appointment of Director, National School of Drama

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH); (a) While there is no post of Additional Education Officer in M.C.D., the number of posts . of Senior Inspectors of School is five.

- (b) and (c) As ascertained from the M.C.D. posts for Scheduled Tribes are reserved as per roster points prescribed. Out of the vacancies filled so far, no post fell on the reserved point for ST.
 - (d) and (e) Do not arise.
