#### Cleaning of Visakhapatnam port

2589. DR. NARREDDY THULASI REDDY: Will the Minister of SURFACE TRANSPORT be pleased to state :

(a) whether it is fact that Visakhapatnam port is facing severe pollution problem with sulphur and iron dust content; and

(b) if so, what action Government propose to take in this regard ?

(d) whether the persons involved in the said recruitment scandal have now been found involved in a sensational diesel scandal at Punjab Roadways, office at Nangal; and

(e) if so, the action Government propose to take in this regard ?

#### राष्ट्रीय जलमार्गों का विकास

2592. श्री ईश दत्त यादव : क्या जल-भूतल परिवहन मंत्री यह बताने की कृपा करेंगे कि :

(क) क्या 1990-91 के दौरान पंजाब परिवहन के लिए राष्ट्रीय जलमार्गों को तीन खण्डों में विकसित किए जाने का कोई प्रस्ताव था ;

(ख) यदि हां, तो इस संबंध में श्रम तथा किए गए प्रयासों का ब्यौरा क्या है ; और

(ग) इनके परिणामस्वरूप लोगों को कौन-कौन सी सुविधायें उपलब्ध होंगी ।

जल-भूतल परिवहन मंत्रालय के राज्य मंत्री (श्री जगदीश टाइटलर) : (क) और (ख) इस समय दो राष्ट्रीय जलमार्ग हैं। वर्ष 1990-91 के दौरान राष्ट्रीय जलमार्ग (गंगा-भागीरथी-हुगली के इलाहाबाद हल्दिया खंड) पर 1.5 मीटर गहरी और 45 मीटर चौड़ी सतत नौचालन नहर सुलभ कराने के लिए हल्दिया और बलिया के बीच नाजुक स्थलों पर बन्दालिश और निक्षेपण कार्य किए गए। राष्ट्रीय जलमार्ग (ब्रह्मपुत्र नदी के सैदिया-घुबरी खंड) पर 2.25 मीटर गहरी और 45 मीटर चौड़ी सतत नौचालन नहर सुलभ कराने के लिए घुबरी और कमाड़ी के बीच नाजुक
