THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI M. L. FOTEDAR): (a) and (b) Government would undertake such a survey and, in the light of the findings of the survey, review the legal provisions for regulating the manufacture and marketing of ayurvedic medicines.

Mosquito nets impregnated with pesticide

@*397. SHRI GURUDAS DAS GUPTA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether it is a fact that mosquito nets impregnated with pesticide have been developed as reported in the Hindustan Times of 21st October, 1991;

(b) if so, whether it may contaminate the air; and

(c) whether it would be safe for children who may touch or lick the nets unknowingly?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI M. L. FOTEDAR): (a) to (c) Yes, Sir. Mosquito bednets impregnated with insecticides have been developed. The insecticides used to impregnate these nets do not contaminate the air and pose no health hazard.

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI M. L. FOTEDAR): (a) and (b) A Bill to amend the Indian Medical Council Act, as reported by Joint Committee of Parliament, contains a provision for conducting a screening test for foreign degree holders.

(c) No such information is available with the Medical Council of India.
