

(b) what is the reaction of Government thereto?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MALLEKARJUN): (a) State Government of Tamil Nadu has requested for the following projects:

(i) New Line from Palani to Cfaam-rajnagar via Dharapur, Tiruppur and Sathyamanglam (145 km.); and

(ii) New Line from Hogenekkal to Tiruvannamallai via Dharmapuri-Morappur, Harur and Theerthamalai (170 km.)

In addition, it was suggested that a Corporation, on the lines of Konkan Railway Corporation, be set up for construction of railway lines in Tamil Nadu.

(b) Due to acute constraint of resources it has not been found possible to take up the projects suggested at (i) and (ii) above.

Regarding the Corporation, this too could not be done owing to the directives of the Planning Commission and Ministry of Finance that no more Corporations be set up.
