BHARDWAJ); (a) and (b) The Finance Ministry have only conveyed to the Planning Commission that the budget support to the Plan for 1992-93 is likely to be maintained at the level for the Annual Plan 1991-92, in nominal terms, in view of the fiscal imbalance being experienced Besides the Central budget support, the Plan size depends on the resources of the Central Public Enterprises and the States' own resources. The assessment of Internal and Extrant Budgetary Resources of the Central Public Enterprises for their Plans for 1992-93 are in progress in the Ministry of Finance. The discussions on the assessment of the States'/UTs' resources for their Annual Plans 1992-93 are in progress in the Planning Commission. A clear picture of the total resources availability for the Annual Plan 1992-93 and the Plan size will emerge only after these discussions are complete by the end of this month.
