As the complaint was a general nature without specific details of assets alleged to be owned, it had not been possible to proceed further in the matter.

Impact of global positioning system on Mapping; technique

3160. SHRI DHULESHWAR MEENA: Will the Minister of DEFENCE be pleased to state:

(a) whether Government's attention has been drawn to the newsitem which appeared in the Hindustan Times', New Delhi dated the 24th November, 1991 captioned "Maps outmoded by satellite";

(b) if so, the impact of the Global Positioning System (GPS) on the traditional mapping technique; and

(c) the steps being taken to promote the use of GPS systems both for defence and commercial uses?

THE MINISTER OF DEFENCE (SHRI SHARAD PAWAR): (a) Yes, Sir.

(b) and (c) Any mapping process consists of a number of steps such as provision of ground control, photogrammetric compilation using aerial photography and satellite imagery, ground verification, mapping and printing etc. The Global Positioning System (GPS) only helps in expediting the provision of ground control. The subsequent steps remain unchanged. It will not be in the interests of national security to disclose further details, in so far as application of GPS for defence uses is concerned.

Medical Reimbursement to army officers
