(b) whether Government are having any price control on this vital drug intermediate used in the manufacturing of a wide range of saving drugs?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI CHINTA MOHAN): (a) To the extent information is available the names of 6-APA manufacturers (for captive consumption/sale) are given in the statement annexed.

(b) As per the provisions of DPCO, 1987, Government is having price control on scheduled bulk drug and formulation. As 6-APA is a drug intermediate, it is out of price control. However while fixing prices of downstream products using 6-APA its price is worked out taking into consideration the notified price of indigenous Pen G, and price of imported Pen. G in the ratio prescribed in the Pen. G distribution policy.
