## Migration from Kashmir Valley

## 94. SHRI MURLIDHAR CHAN-DRAKANT BHANDARE: SHRI BEKAL UTSAHI:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government have noticed any fresh exodus of civilians from the valley following a chain o'f incidents of abductions and increased hostility by militants;
- (b) if so, what is the number of persons who have migrated from the valley during the past three months; and
- (c) what is Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI M. M. JACOB): (a) to (c) No appreciable increase in migration of mnorities from the Valley has been noticed during the last three months. Due to continued terrorists violence, many Muslim families have also reportedlj' come out of the Valley. They are however hesitant to speak and register openly, for the fear of reprisals by terrorists against their relations still in the Valley. The Government is committed to take stern action against the terrorists and to remove the fear psychosis created by them.

# Targets of Terrorists attacks in Punjab

95. SHRI .MURLIDHAR CHAN-DRAKANT BHANDARE: SHRI BEKAL UTSAHI:

Will the Minister of HOME. AFFAIRS be pleased to state:

(a) whether it is a fact that in later part of September, and earlier part of October, 1991, the police personnel and their families became the main targets of terrorists' attacks in Punjab;

- (b) if so, the number of police personnel and members of their fam'lies and their relatives killed during the period from September 15 to to October 15, 1991; the number of terrorists victims during the period and similar figures for the perioc following October 15, 1991 till date and
- (c) the steps taken by Governmen to deal with the situation?

THE MINISTER OF STATE IN THI MINISTRY OF PARLIAMENTARY AFFAIRS AND THE MINISTER OI STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI M. M JACOB): (a) and (b) So as to demo ralise the force, a sustained campaign has been launched against the secu rity forces personnel and their rela tives by the terrorists in Punjab According to information availabl 275 persons were killed between 15t] September, 1991 and 15th October 1991. 61 out of them were polic personnel and 57 others were rela tives of such personnel. Between 16t October and 13th November, 1991 102 persons including 27 policemen were killed.

(c) A number of steps have bee taken by the State Government t ensure the protection of life and pre perty of the police personnel and als to deal with the terrorists threal effectively.

## Demonstration by Joint Council of Service Doctors' Organisation

Will the Minister of HEALTH AN FAMILY WELFARE be pleased t state:

(a) whether it is a fact that th Joint Council of Service Doctor; Organisations organised a black fla demonstration.cum-Dharna out c Nirman Bhavan on September 2 1991 demanding implementation < the Tikku report, unimplemented clauses of 1987 package and the memorandum of settlement of August 21, 1989; and

(b) if so, what is Government's reaction to the demands?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI D. K. THARA DEVI SIDDHARTHA): (a) Yes, Sir.

(b) All the important clauses of 1987 package and Memorandum of Settlement of 1989 have been implemented. Decisions have also been taken on the recommendations of Tikku Committee report. A copy of Office Memorandum No. A-45013/13/ 90-CHS. V, dated 14-11-91 containing these decisions is attached. [See Appendix CLXI, Annexure No. 1]

### Fire in a jhuggi cluster at Govindpuri

- 97. CHOWDHRY HARI SINGH: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that at least 15-16 persons including 10 children were burnt to death in a devastating fire that broke out in a Jhuggi cluster at Govindpuri in South Delhi on September 29, 1991;
- (b) if so, what were the cause thereo'f; and
- (c) what is the quantum of assistance and compensation paid to the victims and their families and the details of the steps that have been taken to resettle them?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND THE MINIS. TER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI M. M. JACOB) (a) Yes, Sir, Sixteen persons died in the incident of fire that broke out in a Jhuggi cluster at Govindpuri in South Delhi on September 29, 1991. Of these, 11 were minors and 5 adults.

- (b) The probable cause of fire was the bursting of a gas cylinder.
- (c) (i) The families of 15 deceased persons have been paid ex-gratia assistance. In the case of adults, the ex-gratia assistance was of Rs. 40 thousand per person and in the case of minors, Rs. 30 thousand per per. son. The compensation includes a sum of Rs. 20 thousand in each case from Prime Minister's Relief Fund. The identity of one [deceased has not been established.
- (ii) Of 1256 dwellers whose Jhuggis were burnt, 1200 persons have been paid ex-gratia relief of Rs. 1500/-each. The remaining 56 persons have not collected the relief amount.
- (iii) A sum of Rs. 10 lakh has been released out o'f Prime Minister's Relief Fund for providing two asbestos sheets to each affected jhuggi dweller. 1170 persons have already collected these sheets.
