

### Adult Education Programme in Arunachal Pradesh

3411. SHRI NYODEK YONGGAM: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state;

(a) whether it is a fact that the funds allocated for implementing Adult Education Programme are being misused in Arunachal Pradesh;

(b) if so, what are the detail\* thereof; and

(c) whether Adult Education Programme is continuing in the State?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): There is no information about misuse of funds allocated for implementation of Adult Education Programme in Arunachal Pradesh.

(b) The question does not arise.

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) The proposed members of the Committee are representatives of political parties and leaders in the field of Social Work.

### Navodaya Vidyalayas in U.P.

3413. SHRI SHANTI TYAGI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to refer to the reply to Unstarred Question 1550 given in the Rajya Sabha on the 6th December, 1991 and state the number of Navodaya Vidyalayas in Uttar Pradesh alongwith the number of Students and teachers in each Vidyalaya?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): Thirty six Navodaya Vidyalayas have been sanctioned in Uttar Pradesh so far. The number of students and sanctioned posts of teachers in 35 Navodaya Vidyalayas are 9319 & 613 respectively. One Navodaya Vidyalaya, sanctioned recently, is not functioning at the moment.

### Distribution of Text Books in Karnataka

3414. SHRI B. K. HARIPRASAD: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state;

(a) whether it is a fact that the Karnataka Government had launched a scheme for distribution of Text Books to the needy students;

(b) whether it is a fact that the said scheme has been hampered due to irregular, insufficient and non-supply of paper; and

(c) whether Government propose to ensure the supply of concessional paper?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (c) Karnataka Government reported in November, 1990 that they introduced a scheme for the supply of nationalised text books to the students of class I to VII and students of class I to X (SC/ST) free of charge and requested for the supply of concessional paper.

Till 31st March, 1990, there was a scheme for subsidised supply of white printing paper for the production of school

text books and exercise books. The scheme was discontinued thereafter.

**Training of police personnel to check atrocities against women**

(a) whether it is a fact that recently a three-day training programme of police personnel was organised in New Delhi in order to examine effective measures to check growing atrocities against women; and

(b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF YOUTH AFFAIRS AND SPORTS) WITH ADDITIONAL CHARGE OF MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF WOMEN AND CHILD DEVELOPMENT) (KUMARI MAMATA BANERJEE): (a) and (b) A three day orientations sensitisation programme for Inspectors/Sub-Inspectors of Delhi Police on "Atrocities against women —Issues and Interventions" was organised from 29-31 October 1991. This was conducted by Joint Women's Programme under the aegis of the Government of India. About 40 participants representing the Inspectors/Sub-Inspectors level in the

Police force attended. The objective of this programme was to sensitise police personnel on various aspects of the handling of the cases involving atrocities on women and to effect a change in the perception of the police regarding women's issues and their problems.
