- (ii) Scheme of Assistance to Voluntary Agencies for undertaking volunteer-based total literacy campaigns in the Districts or a part thereof.
- (iii) Scheme for Assistance to Voluntary Agencies for Non-Formal Education for 6—14 age group Children under the Programme of Universalisation of Elementary Education.
- (iv) There is a provision for financial assistance to Voluntary Agencies under the Scheme of Mahila Samakhya which aims at empowerment and education of women.

There is no special scheme in the Health Sector being implemented only through voluntary organisations. However, grant-in-aid is provided by Government to voluntary organisation for specific work in all Health Sector Programmes including National Health Programmes

The important programmes are as follows:—

- (i) Improvement of Medical Services.
- (ii) Special Health Schemes for rural areas.
- (iii) National T.B. Control Programme
- (iv) National Leprosy Eradication Programme.
- (v) National Programme for Control of Blindness.
- (vi) National Cancer Control Programme.
- (vii) Grant-in-aid to Under-graduate Colleges of ISM and Homoeopathy run by voluntary organisations.
- (viii) National Malaria Eradication Programmes.
- (ix) National Family Welfare Programme etc.
