(ग) क्या यह सच है किङ्केंदिल्ली प्रणासन ने यह सिफारिश की थी कि स्वैच्छिक संस्थाओं को इस कार्यक्रम से सहबद्ध किया जाना चाहिए, यदि हां, तो इस पर सरकार की क्या प्रतिक्रिया है?

मानद संसाधन विकास मंत्री (श्री ग्रजंन लिह): (क) जी हां। साक्षरता, प्रौढँ शिक्षा के चार संघटकों में से एक है, जो संघ शासित क्षेत्र दिल्ली में 2 ग्रक्तूबर, 1978 से लागू है । परिणात्मक तौर पर, कार्यक्रम का उद्देश्य बरीयता केतौर पर 15--35 ग्राय वर्ग के सभी प्रौढ निरक्षरों को साक्षर बनाना है । गुणाबल्तात्मक रूप में, कार्यक्रम का उद्देश्य, शिक्षयों को साक्षरता व ग्रंक ज्ञान में *'*ग्रात्मनिर्भर बनाना, ग्रधिकारों से वंचित रहने के कारणों एवं विकास की प्रक्रिया में उनकी सहभागिता के प्रति उनको जागरूक करना, उनके ग्राथिक स्तर एवं ग्राम दशा को सुधारने के लिए दक्षता प्रदान करने की व्यवस्था करना ग्रौर राष्ट्रीय एकता, पर्यावरण संरक्षण, महिला-समानता और लघु परिवार मानदण्डों ग्रादि जैसे मूल्यों को उनके मन में बिठाना है ।

(ख) सातवीं पंचवर्षीय योजना ग्रवधि के दौरान, कार्यक्रम को बढ़ावा देने के लिए केंद्रीय सरकार के ग्रधीन विभिन्न योजनाग्रों के लिए केंद्र शासित क्षेत्र दिल्ली को 365.57 लाख ध्पए की धनराशि संस्वीकृत ग्रौर जारी कर दी गई है । इसके ग्रतिरिक्त, संघ शासित प्रशासन द्वारा कार्यान्दित की जाने वाली प्रौढ़ शिक्षा की कई योजनाग्रों के लिए उपयुंक्त ग्रवधि के दौरान योजनागत 164.00 लाख ध्पए ग्रांर योजनेतर 243.32 लाख ध्पए का प्रावधान था 1

(ग) स्वैच्छिक एजेंसियों की सहायता योजना को परिशोधित एवं पुनर्गठित किया गया है । मार्ग-निर्देशों के साथ-साथ परिशोधित योजना को संघ शासित क्षेत्र दिल्ली सहित सभी राज्यों/संघ शासित क्षेत्रों में परिचालित कर दिया गया है । परिशोधित योजना और मार्ग-निर्देशों के प्रत्युत्तर में ग्रभी प्रस्ताव प्राप्त किए जाने हैं।

Activities of CARE Incorporated

3400. SHRI SAMAR MUKHERJEE: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) wheter it is a fact that the activities of the American Agency, CARE Incorpo rated,, are limited to feeding programmes in school; and

(b) whether Government propose to review/regulate the activities of CARE?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF YOUTH AFFAIRS AND SPORTS) WITH ADDITIONAL CHARGE OF MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF WOMEN AND CHILD DEVELOPMENT) (KUMARI MAMATA BANERJEE); (a) No. Sir. In addition to feeding programmes in school. CARE-India provides food commodities for supplementary feeding to children below 6 years, expectant and nursing mothers under Integrated Child Development Services Programme. CARE India also provides assistance to some nonfood programmes aimed at increasing the income and improving the nutritional levels of families covered under ICDS programme.

(b) The programme of CARE India are governed by Indo-CARE agreement 1950. Every '-ear CARE-India submits their annual action plan called list of provisions for the approval of Government of India.

Introduction of self Finance Scheme at Higher Educational level

3401. SHRI CHIMANBHAI MEHTA: SHRI SOM PAL:

Will the Minister of HUMAN RE-SOURCE DEVELOPMENT be pleased to state:

(a) whether Government jre aware of the wide spread evil of donation for admission in technical institutions prevailing in various States .and concerned laws and rules of the State Governments have not been effective to prevent or curb this malpractice;

(b) whether Government propose to enforce centralised or regionalised admission system to curb under-hand practice; if so, the details thereof;

(c) what is the per annum expense per engineering student and what is the fees charged in Government and non-Government colleges at present; and

(d) whether Government would intro duce self finance at higher educational level and make loans available to needy students through Banks?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI ARJUN SINGH); (a) Some State Governments where the practice of charging donations in technical institutions was prevalent have passed legislations for banning of the practice. The exact impact is not know.

(b) No, Sir. However, the All India Council for Technical Education (AICTE) has laid down guidelines for admission to engineering colleges and polytechnics with merit/entrance examination as the main criteria.

(c) The expenditure per engineering De gree student is estimated to be Rs. 12,000 per annum. The fees charged in Govern ment .and) Government-aided institutions vary from Rs. 320 to Rs. 750 per annums with an average of Rs. 530 per annum per student. The fee in un-aided Engine ering Colleges various from Rs. 5,000 to Rs 10,000 per annum per student.

(d) The Government is encouraging higher educational institutions to be more self reliant. A scheme is already available with the Scheduled Banks to enable the students to take loans for educational purposes.
