Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state the reasons for not bringing employees of Kendriya Vidyalaya Sangathan within the jurisdiction of Central Administrative Tribunals?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): Kendriya Vidyalaya Sangathan, being a Society under Societies Registration Act, does not automatically come under the Jurisdiction of Central Administrative Tribunal Section 14(2) of the Central Administrative Tribunal Act 1985, empowers the Central Government to issue notification for bringing Corporations/Societies owned or controlled by the Government of India within the jurisdiction of Central Administrative Tribunal in regard to service matters of the employees of such bodies. No such notification for Kendriya Vidyalaya Sangathan, could be issued as the Central Administrative Tribunal is not equipped at present to bear any extra work load.

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF YOUTH AFFAIRS AND SPORTS) WITH ADDITIONAL CHARGE OF MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF WOMEN AND CHILD DEVELOPMENT) (KUMARI MAMATA BANERJEE), (a) and (b) Yes, Sir. The Government resolution constituting the National Youth Council may be seen at Statement attached (*See below*)-

(c) At present, there are 24 vacancies in different categories in the Council. As the Government is considering to revise : the Composition of the Council, there is no move to All up the vacancies at present.
