Training of police personnel to check atrocities against women

- (a) whether it is a fact that recently a three-day training programme of police personnel was organised in New Delhi in order to examine effective measures to check growing atrocities against women; and
 - (b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT YOUTH AFFAIRS AND SPORTS) WITH ADDITIONAL CHARGE OF MINISTER MINISTRY OF OF STATE IN THE HUMAN RESOURCE DEVELOPMENT OF WOMEN AND (DEPARTMENT (KUMARI DEVELOPMENT) CHILD MAMATA BANERJEE): (a) and (b) A three day orientations sensitisation programme for Inspectors/Sub-Inspectors of Delhi Police on "Atrocities against women -Issues and Interventions" was organised from 29-31 October 1991. This was conducted by Joint Women's Programme under the aegis of the Government of About 40 participants representing Inspectors/Sub-Inspectors level in the

Police force attended. The objective of this programme was to sensitise police personnel on various aspects of the handling of the cases involving atrocities on women and to effect a change in the perception of the police regarding women's issues and their problems.

Promotion of U.G.C. Officers

3417. SHRI SATCHIDANANDA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether it is a fact that Class-I Officers of U.G.C. are not being promoted due to stay grant by Court;
 - (b) if so, the number of such officers;
- (c) the number of SC/ST officers in different grades; and
- (d) the action taken by Government to get the stay vacated?

THE MINISTER OF HUMAN RE-DEVELOPMENT SOURCE (SHRI ARJUN SINGH): (a) to (d) According to the information furnished by UGC, the promotion of 16 Group 'A' Officers of the Commission has been affected by the stay granted by the Delhi High Court. No SC/ST Officers is among those affected by the Stay Order. UGC had impressed upon the Hon'ble High Court to vacate the stay on promotions to avoid dislocation of work in UGC due to vacancies at different levels. The High Court partially vacated the stay on 30th October, 1991 thereby allowing promotions upto the level of Section Officer.

Appointment of teachers after retirement

3418. CHOWDHRY HARI SINGH: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether teachers of universities and colleges, after retirement at the age of 60, are eligible for appointments as Visiting Professors in their respective subject; if so, upto what age such appointments may be given to retired teachers;
- (b) whether such appointments are made on the requests by UGC or by interested universities;
- (c) whether the retired teachers are also eligible to apply to UGC for study/research grants on research subjects; and
 - (d) if so, what are the details thereof?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI ARJUN SINGH); (a) and (b) According to the information furnished by UGC, a person who has held the post of a Professor is eligible for appointment as Visiting Professor unto the age of 65 years under the UGC Scheme of Visiting Professorship, Such appointments are made by the Universities themselves in accordance with the Scheme.

(c) and (d) The retired teachers other than those appointed as Visiting Professors can submit major research projects and if such projects are approved by UGC, they are paid an honorarium @ Rs. 2000/per month upto the age of 65 years. In addition, financial assistance is also provided for book's, equipment, contingent expenditure, etc.
