Re-evaluation of importance of Open School Education System

(a) whether any exercise with a view to re-evaluate the importance of the open school education system is proposed to be undertaken to help students become more competitive and better-equipped to face the challenges of life;

The Open Schools of Andhra Pradesh and Punjab have been set up during the calendar year 1991. An overall evaluation of the functioning of the open school system in the country can be undertaken after the system continues for a few more years and is operationalised more extensively.
