THE MINISTER OF CIVIL AVIATION (SHRI SYED SHAHNAWAZ HUSSAIN): (a) to (c) A proposal for developing an airport in Greater Noida by the State Government of Uttar Pradesh was received by the Government of India. However, Government of India pointed out that the existing airport at Delhi can fulfil the future demands of the area on a long term basis. It was further pointed out that the proposed airport falls in the approach funnel of the main runway at Delhi Airport, and is very close to the Tilpat Firing Range of the Indian Air Force. The Government of Uttar Pradesh was advised to undertake techno-economic feasibility study by a professional body so that this airport could be located at a suitable location.

Government of Uttar Pradesh have reviewed the proposal and intimated that the proposed airport is being positioned as an international airport to cater for tourist traffic for Agra at a location to be duly approved by the Government of India, selected on the basis of the techno-economic feasibility report. The State Government is yet to submit a proposal in this regard.

THE MINISTER OF TOURISM AND CULTURE (SHRI JAGMOHAN): (a) and (b) The Ministry of Tribal Affairs has entered into co-production agreement as a co-producer during 2001-2002 for completion of a feature film on Tribal Freedom Fighter Birsa Munda. The production of the film is in progress and is likely to be completed by July, 2002.

Kisan Credit Cards in Gujarat
