

- (i) All efforts will be made to find an amicable resolution of the issue;
- (ii) Pending a final solution, the Government of Uttar Pradesh will hold itself fully responsible for the protection of the Ram Janma Bhumi — Babri Masjid structure;
- (iii) Orders of the Court in regard to the land acquisition proceedings will be fully implemented; and
- (iv) Judgement of the Allahabad High Court in the cases pending before it will not be violated.

The Council welcomed the invitation given to it by the Chief Minister of Uttar Pradesh to visit Ayodhya on any suitable date.

The National Integration Council calls upon all concerned, including the political parties, religious leaders, the media and other organisations, to act with restraint and in a manner that will promote harmony and goodwill between all communities. Everyone must make efforts to desist from words or deeds that are likely to inflame communal passions or give encouragement to disruptive forces. Indian society is traditionally marked by a spirit of tolerance and respect for each other's faith. This spirit should continue to guide our thoughts and actions. The Council appeals to all people to maintain peace and tranquility and create an atmosphere conducive to the satisfactory settlement of the Ram Janma Bhumi-Babri Masjid dispute.

#### **Compensation to Farmers for Damage of Sugarcane Crop**
