## Ragging in Delhi University Colleges

863. SHRI S. S. AHLUWALIA; Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state;

- (a) whether it is a fact that ragging has been banned in the campus of the Delhi University; and
- (b) if so, whether Government propose to ban ragging in all other Universities in the Country?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH); (a) Ragging in any form was banned under the existing Ordinance XV-B of the University of Delhi. The Executive Council of the University passed a new and detailed Ordinance XV-C on 5.10.91 strictly prohibiting ragging within the premises of all Colleges and Departments of the University as well as on public transport. The new Ordinance

provides for stringent punishment, including rustication and expulsion, for students found guilty of ragging.

(b) Government has drawn the attention of Vice-Chancellors of all Universities, Directors of IITs, Principals of Regional Engineering Colleges and Education Secretaries of all States/UTs to some recent incidents of ragging and requested them to take immediate steps to put a stop to this undesirable activity and to provide new students conditions in which they feel welcome and comfortable

## Discovery of copper in Orissa

- (b) The Geological Survey of India (GSI) have proved 1.66 million tonnes of copper ore with an average of 1.59 per cent copper at Kesharpur in Mayurbhanj district and 1.81 million tonnes of copper ore with 1.04 per cent copper at Adash in Sambalpur district of Orissa.
- (c) Orissa Mining Corporation, a State Government Undertaking, have since applied for grant of prospecting Licence for copper in these areas
