Diminishing Trend in Rayda Production

- (a) whether Government's attention has been drawn to the findings of a survey conducted by Mustard Research and Promotion Consortium, regarding the diminishing trend in Rayda Production by the Cultivators;

(b) what has been the production of Rayda during 1998-99, 1999-2000 and 2000-2001;

(c) whether it is a fact that due to import of other edible oils, the Rayda crushing mills are on the verge of closure; and

(d) if so, how Government propose to save Rayda mills and Rayda growers in the country?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI HUKUMDEO NARAYAN YADAV): (a) and (b) The production of Rapeseed & Mustard (Rayda) remained fluctuating depending upon the behaviour of monsoon. The decline in the production of Rayda (Rapeseed-Mustard) during last two years has been mainly due to drought like conditions prevailing in the major mustard growing States.

The total production of Rayda (Rapeseed-Mustard) during the last 3 years is given below:—

Year	In 000 tonnes Production
1998-99	5663.9
1999-2000	5958.2
2000-2001	4090.0 (Advance estimates)

(c) and (d) There has been a huge import of edible oil due to low import duty. This also led to fall in the prices of indigenous oilseeds including Rayda (Rapeseed-Mustard). As per the information available, the capacity utilization of the oil processing mills including solvent units has been around 35-40%.

In order to save the Rayda (Rapeseed-Mustard) growers and the industries, a Centrally Sponsored Oilseeds Production Programme (OPP) is in implementation in various States of the country for increasing the production of oilseeds including Rayda (Rapeseed-Mustard). Under the programme financial assistance by way of subsidy to the farmers is provided for various inputs in order to motivate them to take up the cultivation of oilseeds including Rayda (Rapeseed-Mustard) on a large scale. The import duty on Rapeseed-

Mustard oil has also been increased to the bound rate of 75% with effect from the 1st March, 2001.
