REFERENCE TO MURDER OF TWO WOMEN BY THEIR BROTHERS IN **HARYANA**

SHRIMATI JAYANTHI NATARA-JAIN (Tamil Nadu): Madam, I want to bring bring to the notice of the House a gruesome and tragic incident that happened at Hissar in Haryana where two young women aged 25 and 30 were backed to death by their own brothers. The brothers were aged 22, 18 and 16. We have been talking so much about the various important issues relating to the economy, unity and integrity of the country, etc. But one thing which we have not yet taken seriously is the fact that the lives of women in this country are not safe. It is not only that they lead lives of abject poverty and discrimination but they do all the work and nobody takes them seriously. Nobody takes interest in their development. They are discriminated by others in every possible way and in every possible field. They do not have the right to live. In the village ,of Rattangarh in Haryana, these two young girls were hacked to death. They have seven children between them and they belonged to the
