Shareholdings in Mangalore Refinery

3010. SHRI BRAHMAKUMAR BHATT: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) the details of persons who are holding share capital above 25 per cent in Mangalore Refinery and Petro-chemicals;

(b) the quantum purchased by Aditya Birla Group in the said shareholding; and

(c) whether there is any proposal to purchase the Aditya Birla Group's stake in the Mangalore Refinery and Petro-chemicals by the HPCL?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH GANGWAR): (a) and (b) Hindustan Petroleum Corporation Limited (HPCL) and A.V. Birla Group (ABG), the joint promoters of Mangalore Refinery and Petrochemicals Limited (MRPL), are holding 37.38% shareholding each in MRPL.

(c) ABG has expressed its intention to exit from MRPL. The purchase of ABG stake in MRPL by HPCL has not been concluded so far.

Exploration of oil in Tamil Nadu

3011. SHRI KA. RA. SUBBIAN: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) the number of excavation of wells for petroleum and natural gas in Tamil Nadu has taken place for the last five years;

(b) if so, the details thereof district-wise; and

(c) if not, whether Government would consider exploring Tamil Nadu coast for petroleum and natural gas?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH GANGWAR): (a) and (b) During the last five years (1996-97 to 2000-01), Oil and Natural Gas Corporation Ltd. (ONGC) has drilled 104 number of exploratory and 9 development wells in the State of Tamil Nadu. The details of exploratory and development wells drilled, district-wise are given below:-

(c) In addition to above, ONGC is actively engaged in exploration for hydrocarbons in the coastal areas of Ramnathapuram district. Further, Production Sharing Contracts (PSCs) for six exploration blocks in Cauvery offshore, off the coast of Tamil Nadu have already been signed with different National and Private oil companies, which include two blocks awarded in the first round and two blocks awarded in the second round of New Exploration Licensing Policy (NELP). Some exploration blocks in deep waters off the coast of Tamil Nadu are also being contemplated to be offered in future rounds under NELP.
