(a) whether it is a fact that the work of expansion of airports at Vijayawada and Tirupati in Andhra Pradesh is in progress;

(b) if so, what are the details thereof; and

(c) by when the work is likely to be completed at these airports?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION (SHRI HARMOHAN DHA-WAN): (a) Yes, Sir.

(b) The details of work to be executed are as follows: —

(1) Expansion and strengthen ing of Runway to 7500 feet.

(2) Widening and Strengthening of taxi-track;

(3) Widening and strengthening of apron;

(4) Construction of new terminal building at Vijayawada and new terminal building and control tower at Tirupati.

■ (c) The duration for completion of work is 30 months from the date of award of contract.
