A three member World Bank team was in India during January-Febia-ary. 1991 for review of the progress of on-going projects. This team during their meetings (in Coal India

Ltd. and Department of **Coal**) had discussed various issues related to coal projects. One of the points discussed was the ways and means to improve financial performance of Coal. Sector. During discussions the modalities of redeployment of surplus workers from mines that are closed down due to exhaustion of reserves and reduction in unproductive manpower with a view to improving output per manshift were also discussed.

These points were discussed generally and neither any figure about excess number of workers was mentioned nor this was posed as conditionally to any loan sought from the World Bank.
