THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI BA-RANRAO DHAKNE): (a) to (c). The suitability of the proposed site for Krishnapatnam Thermal Power Sca-tion was considered by the Site Selec tion Committee. The Indian Meteorological Department (IMD) have opined that the site is located in the cyclone prone area. The Central Electricity Authority. have suggested to the APSEB to examine the compatibility of the site keeping in view the recommendations of the Site Selection Committee and the expenditure involved for the following amenities: -

(i) The safety measures proposed to be adopted to meet any eventuality in the event of cyclones.

(ii) Broad gauge railway siding of 25 Kms length.

(iii) Supply of sweet water from Kandaleru reservoir through 50 Kms long pipeline of suitable capacity with stand-by arrangements for boiler make-up etc.

(iv) Development of port which according to M/s. RITES would involve high initial development and further maintenance due to flatness of sea bed.
