THE MINISTER OF PETROLEUM AND CHEMICALS AND PARLIAMENTARY AFFAIRS (SHRI SATYA PRAKASH MALAVIYA): (a) Yes Sir, Govt, has recently approved the following two projects of ONGC in Western Offshore region.

- (i) Project for development of Neelam field in Western Offshore.
- (ii) Project for development of Mukta field in Western Offshore.

(b) Estimated cost of the Neelam project is Rs. 2022. 20 crores and the project is expected to yield 63. 19 million tonnes of oil and 8. 558 billion cubic metres of gas over a period of 21 years. The Estimated cost of the Mukt_a project is Rs. 1319. 01 crores and the project is expected to yield 15. 041 million tonnes of oil and 3. 851 billion cubic metres of gas over a period of 21 years.
