

मानव संसाधन विकास मंत्री (श्री राजमंगल पाण्डेय) : (क) वर्ष 1985-86 और 1989-90 के बीच अंग्रेजी में प्रकाशित 244 पुस्तकों में से 64 मौलिक पुस्तकें थीं। हिन्दी के तुलनात्मक आंकड़े क्रमशः 458 और 35 थे।

(ख) उपरोलिखित अवधि के दौरान अंग्रेजी और हिन्दी में प्रकाशित अनुवादों की संख्या क्रमशः 3 और 43 थी।

(ग) न्यास अंग्रेजी को वरीयता नहीं दे रहा है और हिन्दी तथा अन्य भारतीय भाषाओं की उपेक्षा नहीं कर रहा है। अंग्रेजी में प्रकाशित होने वाली पुस्तकों की संख्या अन्य भाषाओं में प्रकाशित होने वाली पुस्तकों की संख्या से बहुत कम है। तथापि, अंग्रेजी में और अधिक मौलिक पुस्तकें प्रकाशित की जाती हैं क्योंकि न्यास की कुछ प्रकाशन श्रृंखलाओं जैसे पापुलर साइंस और इंडिया दि लेंड एंड दि पीपुल के लिये उपयुक्त लेखक उपलब्ध होते हैं।

(घ) न्यास कार्यशालाओं, सेमिनारों इत्यादि के आयोजन के माध्यम से भारतीय भाषाओं के लेखकों को प्रोत्साहित करके विभिन्न भारतीय भाषाओं में मूल पुस्तकें तैयार करने का प्रयास कर रहा है।

#### Retrenchment of employees in coal industry

A three member World Bank team was in India during January-February, 1991 for review of the progress of on-going projects. This team during their meetings (in Coal India

Ltd. and Department of Coal) had discussed various issues related to coal projects. One of the points discussed was the ways and means to improve financial performance of Coal Sector. During discussions the modalities of redeployment of surplus workers from mines that are closed down due to exhaustion of reserves and reduction in unproductive manpower with a view to improving output per manshift were also discussed.

These points were discussed generally and neither any figure about excess number of workers was mentioned nor this was posed as conditionality to any loan sought from the World Bank.

(b) whether it is also a fact that according to Pilot's Association ignoring of the speed is not a cause of the plane crash;

(c) whether the French Pilots had also found technical faults in operations of A-320 Airbus;

(d) what are the findings of the Court of Inquiry that have not been accepted by Government; and

(e) what was the basis on which the Prime Minister adjudged A-320 plane as the best operating aircraft?
