SHRI M. S. GURUPADASWAMY. (Karnataka): May I make a short submission, Sir? A vote-on-account is not a new thing in Parliament, I agree. A vote-on-account is taken when an election is imminent and there is no time to present the budget That is one thing In the First Parliament Sir, when elections were held rather late, this was resorted to; a vote-on-account was taken. The old Parliament was called. A vote-on-account was taken. There are insignant where a vote-on-account is taken for a very thank parliad.

SHRI JAGESH DESAI (Maharashtra); when did you present the budget? (Interruptions)

SHRI M. S. GURUPADASWAMY: Please listen to me. It is taken for a very short period without forgoing or postponing the budget.

SHRI SURESH KAMADI: When did the Janata Dal bring the budget?

SHRI V. NARAYANASAMY (Pondicherry): Not on February 28, You brought it on March 26.

SHRI M. S. GURUPADASWAMY: A vote on account is taken for a month or two to three months, Sir, not for the whole period.

SHRI V. NARAYANASAMY: Don't behave as saints. (Interruptions)

SHRI M. S. GURUPADASWAMY: Sir, the Finance Minister is ready with his budget. He worked very hard. He is ready with the Budget.

THE VICE-CHARMAN (SHRI BHASKAR ANNAJI MASADKAR): He is here.

SHRI M. S. GURLIPADASWAMY:
He is here: That is what I am saying.
But it was shelved. (Interruptions)
My point is that the presentation of
the Budget should not depend upon
extraneous, partisan, and narrow political considerations. If the Budget

SHRI YASHWANT SINHA: I will tell you the reasons when I come with my statement. When I come with the General Budget, I will tell you the reason.

THE VICE-CHAIRMAN (SHRI-BHASKAR ANNAJI MASODKAR); Do you want to respond, Mr. Sinba? ... (Interruption) ... If you respond that will again go on. (Interruptions)

I request all of you to take your seats: Let us finish the point of order. Let us finish it. (Interruptions) I don't think there is any point of order and the Government is entitled to bring a Vote-on-Account to this House...

SOME HON. MEMBERS: It is not a Vote-on-Account (Interruptions)~

THE VICE-CHAIRMAN (SHRI.

Just listen to me. ... (Interruptions) ... Would you listen to me or not?

SHRI DIPEN GHOSH: I am on a point of order, Sir. I want to know whether there is a Vote-on-Account for the entire year because it has been mentioned that it is for the whole year. (Interruptions) Similarly, in my view...

SHRI JAGDISH PRASAD MAHUR: Sir,...

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAR): I have not permitted you, Mr. Mathur I have not permitted you. Nothing will go on record.

SHRI JAGDISH PRASAD MATH-UR'*

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAR): I am in the midst of my statement. Please sit down, Mr. Mathur. Please down. Would you please sit down? Mr. Mathur, a senior Member like you, when I am in the midst of giving a ruling, should not interrupt. I was just trying to dispose of the point of order. I said that the Government is entitled to lay before this House the Vote on Account and there is no impropriety in it. Article 112 which has been relied upon does not prohibit the Government from this procedure. In fact, Article 116 of the Constitution is enabling. So, there is no point of order. Now, Minister ... (Interrupthe Railway tions)...

SHRI PARVATHANENI UPEND-RA: In protest we walk out.

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAB): Mr. Bhekta Charan Das, please lay Sir, I beg to lay on the Table a statement (in English and Hindi) of the estimated receipts and expenditure of the Government of India for the year 1991-92, in respect of Railways.

DISCUSSION ON GULF WAR-

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAR): Now, the question is whether the House should take the Special Mention or the Gulf situation. Let us finish the Gulf situation because it is half-way.
