LPG Bottling Plants in Tamil Nadu

3014. SHRIMATI S. G. INDIRA : Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) the number of LPG bottling plants set up in Tamil Nadu during the last two years;

(b) whether it is proposed to set up a LPG bottling plant at Sivaganga district in Tamil Nadu;

(c) if so, the details thereof; and

(d) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH GANGWAR): (a) Public Sector Oil Marketing Companies have set up 3 LPG bottling plants in Tamil Nadu during the period 1.4.1999 to 1.4.2001.

(b) to (d) At present, there is no plan to set up an LPG bottling plant at Sivaganga District in Tamil Nadu as the present demand of the area is being met in full through the existing bottling plant at Madurai.

THE MINISTER OF TOURISM AND CULTURE (SHRI JAGMOHAN) : (a) to (c) Sixty monuments/sites in Punjab and four in Himachal Pradesh have been declared as State monuments since independence. The names of monuments and the notification details are in Statement I (*See below*).

(d) to (f) Five monuments in Punjab and twenty-three in Himachal Pradesh have been declared as national monuments since independence. The names of the monuments and the notification details are in Statement II.
