## Failure of Pensi Foods Private Limited to meet Export Obligation

SHRI DIPEN GHOSH (West Bengal): Mr. Vice-Chairman, Sir [ want to draw the attention of the Government, through you, to a very important issue, particularly in the presence of the Leader of the House who happens to be the Finance Minister. He and I, when we were on the same side, had the opporunity to raise this issue when the Congress-I was in power or when Mr. Sinha belonged 10 the ruling party and I belonged to a party, supporting the ruling party at this time. I remember -when this issue was raised, I and the present Finance Minister were in the Opposition. I raised this issue and the Finance Minster himself supported me. It was regarding grant of permission to Pepsico for setting up a project here for manufacture of soft drinks and some prepared foods like potato chips etc. I would like to draw the attention of the present Finance Minister to his own statement when

he said, recalling the Cola episode-at that time Mrs. Gandhi was the Prime Minister—; "Mrs. Gandhi's Government went and with the going of Mrs. Gandhi's Government, Cola was also going". He himself said that at the time when Mrs. Gandhi was in power. Later he again said: "Mr. Gandhi would go and with his going Pepsi would also go." But unfortunately, despite all our protests and opposition, pepsico was given the permission and licence on certain terms for setting up its unit at Punjab. And this was done during the previous Government's tenure when Mr. Yashwant Sinha himself was in the then ruling party. And at that time though we were supporting the then Government, but from) our party side we opposed that. From the agreement which they entered into and the commitments which Pepsico made, it is observed that none of the provisions, none of the commitments that they made, has been fulfilled, whether it is about the export obligation, whether it is about the percentage of manufacture of soft drinks and other products, whether it is about the cost of projects or anything else. So, Pepsico failed to meet all the commitments, including the export obligations which they have made or which they had been told to do by the Government while granting the licence. Pepsico had failed. Recently a Committee was set up after a discussion in the consultative Committee of the Food Processing Ministry and the Committee was set up by the Ministry of this Government of which Mr- Yashwant Sinha is the Finance Minister and that Committee had submitted its report to the Government. And that Committee in its report has concluded that Pepsico has failed to meet its export obligations and they have found that Pepsico has not procured the plant for extraction of pure juice and has not made any arrangement to acquire the fusion technology for concentrating fruit juice to save energy and to retain flavour, though Pepsico in its project proposal had stated that pure concentrate would be used in the manufacture of the softdrink which is

SHRI SURESH KALMADI: I do not know what subject. I came late,

marketed by Pepsi in the U.S. The report says that the construction cost of the building and other equipments has also gone up from Rs. 22 crores to Rs. 75 crores. The number of people they were supposed to recruit an dap-point, they have not done. So, on all counts Pepsico has failed to fulfil the obligations and commitments made. Now, the Government says that report is under consideration. I do not know, how long it will remain under consideration, because, according to the statement of my hon. colleague, now the Finance Minister, Mr. Yashwant Sinha, Rajiv Government had gone but Pepsico did not go, it stayed. Now, Mr. Yashwant Sinha himself is the Finance Minister. And may I request the Government, through you.....

THE VICE-CHAIRMAN (SHR1 BHASKAR ANNAJI MASODKAR): You please conclude. This is a special Mention.

SHRI DIPEN GHOSH ...that before this Government goes—this Government is found to go as the situation obtains today—at least, the report which has been submitted to the Government about the failure of Pepsico to meet the obligations should be persued by the Government and action taken against Pepsico. That I want to know from the Government and, I hope, since Mr. Yashwant Sinha himself is the Finance Minister of this Government, he would take all the steps to expedite the Government action against Pepsico for not fulfilling the commitments and obligations they had made in their proposal. Thank you.

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAR): Mr. Kalmadi, do you want to associate with this?

SHRI SURESH KALMADI (Maharashtra) No.

THE 'VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAR): On this very same subject.

SHRI SURESH KALMADI: I gave a Special Mention. But I do not want to support Mr. Dipen Ghosh.

BHASKAR ANNAJI MASODKAR): This

THE VICE-CHAIRMAN (|3HRI BHASKAR ANNAJI MASODKAR): But your name is specified.

SHRI SURESH KALMADI; That is up to the Secretary-General.

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAR): All right. Go ahead.

SHRI SURESH KALMADI: Sir, as you are aware, when the Pepsi proposal came there were various views in the Parliament-some were against it and some were for it. I, for my part opposed it tooth and nail. But the party took a different line. We were given to understand that Pepsi is generally interested in promoting the cause of the farmers of Punjab, that it firmly believed in setting up food processing units in Punjab, that it would export the produce from Punjab, that it will set up an Agricultural Research Institute in Punjab and on all these counts commitments were made by Pepsi and. therefore, people like me, did forgo our objection. We said all right, this is going to happen in the interest of Punjab, there will be more job opportunities. We said it is all right arid Pepsi did come into the country. They gave a lot of commitments, but, as Mr. Dipen Ghosh said, they are backing out of their commitments. This action of Pepsi will undermine many more projects which might be coming India. If they are not going to keep up to the export commitment, if what all they promised to this country is not going to come up, it is indeed a very bad tiling and severe action mast be taken against

this particular company. The three-member committee constituted. . .(time-bell ring) I am not going into the details. Why are you impatient? I am just mentioning it. I am not going into the details. ..

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAR): You know the rule, that you need not repeat what he has said.

SHRI SURESH KALMADI: I am just saying I am not going into details because you have already said it. At least allow me to say that.

The only thing they did very well was the soft-drink plant. That plant they did very well. And the cost of the project has gone up three times. I do not know where the money has gone, where the money has been spent. All the equipment seems to be overinvoiced, all the billing overinvoiced. I think a thorough inquiry must be held by the Government. It is clear that the trust and confidence of the Government of India and the country in Pepsi has been betrayed. It was said that Pepsi would bring in a flood of foreign investment. In fact, Pepsi has done a great deal of damage to the multinationals. It is now clear that Pepsi has no intention far food processing and Pepsi has no expertise or knowhow in food processing. Their only interest was soft drinks and potato chips. With these words I would request the Government to look into the matter and make sure that Pepsi keeps up its commitment; otherwise till such time that Pepsi keeps up Its commitment its soft drinks plant should be closed down, because they were allowed to manufacture soft drinks only on the condition that they would fulfil all the export obligation and export obligation means that the produce of the farmers of Punjab—not an item like trucks-their fruits and fruit juice alone from Punjab must be exported.

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAII MASODKAR): Shri Gurudas Das Gupta. Not here. Shri Shankar Dayal Singh.

Dismissal of the Governor of Bihar
