3. The capital cost will be shared equally between the Centre and the States. The operation and maintenance will be the responsibility of the States.

"Gomti and Ganga cleaning Plan"

SHRI PRABHAKAR RAO *147. KALVALA: Will the Minister of EN-VIRONMENT AND FORESTS be pleased to state:

- (a) whether the Gomti (Uttar Pradesh) and Ganga Cleaning Plan is not going according to schedule;
 - (b) if so, the reasons therefor;
- (c) what amount has been spent so far on the above plans separately; and
- (d) by when, the above projects are likely to be completed?

THE MINISTER OF COMMERCE WITH ADDITIONAL CHARGE OF MINISTRY OF AND THE LAW **SUBRAMANIAN** JUSTICE (DR. SWAMY): (a) and (b) 261 schemes have been sanctioned under the Ganga Action Plan for the River Ganga. This Plan does not cover River Gomti. 159 schemes have been completed so far. While there is some slippage in some schemes due to reasons such as litigation in courts, the others are keeping up the schedule.

- (c) An amount of about Rs. 215 crores has been spent so far under Ganga Action Plan.
- (d) It is expected that the remaining schemes would be completed by June, 1993.

Proposal to Import **Telecommunication** equipment from Japan

- *148. SHRI JAGADISH JANI: Will the Minister of COMMUNICATIONS be pleased to state:
- (a) whether Government have a proposal to import telecommunication equipment from Japan;
- (b) if so, what are the details of equipment which is proposed to be imported and the cost of the import bill;

- (c) whether any other country was also contacted for procuring the equipment: and
 - (d) if so, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (DR. SANJAY SINGH): (a) Yes, Sir.

(b) to (d) The proposals to import telecommunication equipment from Japan are as follows:

NEAX

[RAJYA SABHA]

There is a proposal to import 1,41,900 lines of expansion of existing 159 exchanges of NEAX type. The f.o.b. cost of the import is Japanese Yen 1563 million. Since these equipment are for expansion of existing exchanges, a quotation from the original supplier was ob-The financing for this proposal would be from OECF credit. Orders for this equipment will be placed only after obtaining due clearances of the Government and the Financing Agencies.

CTMX

In order to modernise the Manual Trunk Exchanges, the Department decided in 1987 to import fully automatic Operator assisted computerised digital trunk manual exchanges (CTMX) for 8 big cities. Accordingly global tenders were issued in 1987 under loan from Asian Development Bank after getting the concurrence from the associated Ministries. However, before the orders could placed, the Telecom Commission was formed who decided not to import the items which could be developed in the country. Consequently the procurement of CTMX exchanges was dropped and the ADB intimated about the dropping of this proposal. However, the development of this equipment indigenously did not materialise and therefore the proposal to import CTMX was revived. A Japanese company was the lowest approved party in the earlier tender. However, the proposal is still in a preliminary stage.

"Committee for examining measures to check pollution"

*150. SHRI SURESH KALMADI: Will the Minister of ENVIRONMENT
