#### **Electronic Exchanges for Telephones**

(a) the number of cities and rural units covered by electronic exchanges for telephones;

(b) whether there is any proposal to hand over telephone communication to private corporations; and

(c) if so, what are the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI JAI PARKASH). (a) Out of a total of 14322 telephone exchanges as on 31.3.1990, 778 exchanges are of electronic type covering various cities and rural areas.

(b) No, Sir. There is no proposal to hand over telephone communication to private corporations. However, the Government has appointed a High Level Committee to suggest most appropriate organisational structure for the Telecom Department, keeping in view the operational and developmental needs and financial implications thereof etc.

#### **Critical Analysis of the Working of C-DOT**

(a) whether it is a fact that the entire special group trained at AT&T in USA has left the centre for development of telematics (C-DOT) and that the organisation continues to be plagued with manpower drain;

(b) whether any critical analysis of the working of the organisation has been made by Government;

(c) if so what are the details thereof; and

(d) the manner in which Government propose to improve the situation?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI JAI PARKASH): (a) C-DOT has about 400 Engineers in the organisation. Out of these 5 Engineers were trained in USA and 4 of them have left C-DOT on expiry of their service bond. However, other engineers have been assigned these jobs.

(b) to (d) A critical analysis of the C-DOT has been made by an Expert Committee appointed by Government. Report of the Committee is under examination.
