Loans for purchasing ready Built Houses from State Housing Boards

1208. SHRI JAGADISH JANI, Will the Minister of URBAN DEVELOP-MENT be pleased to state:

- (a) whether the Central Government employees can get loans to by ready built houses from any State Housing Board:
- (b) if not, the State Housing Boards from which ready built houses cannot be purchaseed by Central Government Employees with Government loan; and
 - (c) the reasons therefor?

THE MINISTER OF URBAN DEVELOPMENT (SHRI DAULAT RAM SARAN): (a) to (c) Yes, Sir. House Building Advance is admissible for the purchase of ready-built houses by the State Housing Boards or other, on cash down basis but not on hire-purchase basis. In respect of flats under Self-financing schemes of the State Housing Boards, the grant of house building advance is conditional upon the Housing Boards' accepting certain standard terms and conditions.

Improvement in Railway Catering

1209. SHRI JAGADISH JANI: Will the Minister of RAILWAYS be pleased to state:

- (a) whether Government have recently taken some steps to improve railway catering:
- (b) if so, what specific steps have been taken in South Eastern Ralway;
- (c) whether the catering services available in the trains running between New Delhi and Puri are far from satisfactory; and

(d) if so, the steps taken to improve the catering services in those trains?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI BHAKTA CHARAN DAS): (a) Yes, Sir.

- (b) Steps taken include provision of modern kitchen appliances, eliminating use of charcoal by use of LPG, training of staff, revision of menu, intensive inspections, etc.
- (c) and (d) Catering services by these trains are considered satisfactory. However, steps mentioned in part (b) have been taken to improve the service further

Scheme for Rural People in ITDC Hotels

- (a) whether Government have assessed the reaction of the rural people and the experience of the ITDC staff to the scheme launched by ITDC to attract rural people to visit five star hotels and resturants; and

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRIMATI USHA SINGH): (a) and (b) The scheme offering meals on concessional rates to rural gests in ITDC hotels has only been lauched recently on 25-1-91. Consequently, ITDC has not yet made an assessment of the reaction/response of the rural people and ITDC hotel staff to this scheme.

Master Plan for Delhi-2001

THE MINISTER OF URBAN DEVE-LOPMENT (SHRI DAULAT SARAN): (a) and (b) Modifications in the Master Plan for Delhi-2001 were made after due notice to the public and after considering objections and sugestions received in response thereto.

(c) Does not arise in view of (a) and (b) above.

रेल मंत्रालय में राज्य मंत्री (श्री भक्त चरण दास) (क) ग्रीर (ख) दक्षिण ग्रीर पश्चिम की भ्रोर जाने वाली गाडियों सहित सभी गाडियों में मौजदा मानदंडों के भ्रतसार सविधाओं की व्यवस्था की गयी है, यातियों के लिए सूख-सुविधायों का उन्नयन तथा सुधार करना एक सतुत प्रक्रिया है । हाल ही में गाड़ियों में कुछ म्रतिरिक्त सुविधामों की व्यवस्था की गयी है जिसमें दूसरे दर्जे के ध्यन-यानों में गदिदयां लगाने, परीक्षण के तौर पर कुछ गाड़ियों में पाने के कूलर लगाने, वाता-नुकुल शयनयानों में बिस्तरों, कुछ सुपरफास्ट गाडियों में गाडी अधिक्षकों का चलना, चुनी हुई गाडियों में चल गाडी सफाई कर्म चारियों, बड़ी लाइन के सवारी-डिक्बों में पानी की टंकी की क्षमता में 1,262 लिटर से 1,820 लीटर तक की वृद्धि करना भ्रादि शामिल है।

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRI-MATI USHA SINGH): (a) and (b) The Tourism Development Ellora-Ajanta Region with an estimated cost of Rs. 195.6 crores has been posed for assistance from the Government of Japan and is under consideration.

THE MINISTER OF STATE IN THE OF TOURISM (SHRI-MINISTRY MATI USHA SINGH): (a) There has been decline of abut 20 per cent in foreign tourist traffic to India, excluding the nationals of Pakistan Bangladesh during January, 1991 as compared to the arrivals during the same month of the previous year. The decline is primarily due to the Gulf war.
