- (b) to (d) In the case of Government servants, who have been allotted Government accommodation for the first time the issue of ration cards is regulated as indicated below;
  - (i) For a Government servant who did not have a ration card in his own name but was included in another family ration card, new ration cards would be given after his name is deleted from the other family ration
  - (ii) In case of those Government servants who did not have ration cards in the past were allotted Government accommodation for the first time ration cards are given after satisfying the conditions mentioned in the Anne-xure.
  - (iii) Government servants who come to Delhi on transfer and are allotted Government accommodation for the first time are not required to produce surrender certificate of ration cord from the authorities of the area of their previous
