- 1115. SHRI A. NALLASIVAN: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:
- (a) whether it is a fact that the Food Corporation of India Employees Union Madras has been urging for a discussion with the FCI management on some points arising out of the implementation of the transfer policy in the Southern Zone;
- (b) whether their request for a meeting was conceded:
- (c) if so, the outcome of the said meeting:
- (d) whether the meeting was attended by the representative of the FCI southern zone management;
 - (e) if not, the reasons thereof; and
- (f) whether proper meeting is being discuss the said transfer arranged to policy; if so, the details thereof?

THE MINISTER FOOD AND (SHRI SUPPLIES **RAO** CIVIL BIRENDRA SINGH): (a) Yes, Sir.

(b) Yes, Sir. Food Corporation of India reported that a was convened on 9-11-1990 at FCT Headquarters, Zonal Manager (South) also convened a meeting with representatives of the Union on 8th & 9th February, 1991 at Madras.

- (c) During discussions, (South) ZM assured representatives of FCI Employees Union, South Zone of redressal of grievances, particularly the anomalies in transfers that have arisen on account of computerisation.

THE MINISTER OF RAILWAYS (SHRI JANESHWAR MISHRA): (a) Yes, Sir.

Payment of dues of M/s Ring Road Carrier Delhi

- (a) whether Government have received any representation from M/s Ring Road Carrier, Delhi about non-payment of their dues for the jobs they have rendered to the National Seeds Corporation of India Ltd.;

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHR! JAYANTILAL VIRCHANDBHAI SHAH): (a) Yes, Sir.

(b) and (c) According to information made available by the NSC, it has been indicated by the Corporation that M/s. Ring Road Carriers were registered as transport agency with the NSC Regional Office at Bangalore for transport of seed to Patna Region. The agreement between the transporter and the NSC had provided for delivery in ten days. Most of the consignment were despatched in February and early March, 1987. Various consignments of maize seed were received by the Regional Office of NSC at Patna after considerable delay. Since the consignment ar-

rived at the destination site very late, well past the sowing season, the seed had deteriorated in quality during the long transit period, the NSC had imposed penalty under the agreement with the transporter, for delays in delivery and consequent losses. According to the corporation no amount is due for payment to the transporter from the NSC.

- 2. Only three grades are available for the pharmacists. They should be given promotion upto Class I gazetted rank and the same should be intime bound basis.
