

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE AND THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DIGVIJAY SINGH): (a) and (b) In terms of section 9(1) (a) of the RRBS Act, 1976 (As amended in 1988), the Central Government nominates two non-official directors on the Board of each Regional Rural Bank. Central Government has, therefore, to nominate a total of 392 non-official directors on the Boards of 196 Regional Rural Banks. As per records 230 non-official directors have completed their term of two years, 70 are yet to complete the two year term and the remaining 92 posts are vacant. The bank-wise position of number of non-official directors, who have completed the two year term and are continuing is given in the ~~annexure~~. (See Appendix CLVII, Annexure No. 24)

(c) The appointment of non-official directors in Regional Rural Banks as the Central Government nominees, is a continuous exercise, and as such no time frame for the same can be stipulated.

**Vacant posts of District Savings Officers in National Savings Organisation.**

1021. SHRI A. NALLASIVAN: Will the Minister of FINANCE be pleased to state;

(a) what are the reasons for keeping nearly 160 posts of Field Officers (District Savings Officers) vacant in the National Savings Organisation;

(b) whether it is a fact that these vacancies have remained unfilled since 1989; and

(c) what steps Government are taking to fill up these vacancies?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE AND THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DIGVIJAY SINGH): (a) to (c) A proposal to restructure the National Savings Organisation (NSO) with a view to making it more effective is under the conside-

ration of the Government. Pending the completion of process of restructuring, it has been decided to keep these posts vacant.
