THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI RAJIV PRATAP RUDI): (a) Yes, Sir. As per the provisional data available from the Directorate General of Commercial Intelligence and Statistics (DGCI and S), Calcutta, India's exports have increased to US \$ 44.56 billion during 2000-01 from US \$ 18.14 billion during 1990-91. India's export, in dollar terms, registerd a growth of 21% during 2000-01 over the last year.

(b) and (c) The percentage share of India's merchandise exports in world merchandise exports which was 0.5% in 1990 increased to 0.67% in 2000 as per the latest WTO Report.
