the coast. In the second stage, a "Cyclone Warning" is issued 24 hours in advance of the Cyclones anticipated landfall. The ports are warned by means of a Special Port Warning Service. Warnings for Fisheries Officials and Ports start much earlier formatory messages are issued to All India Radio and Doordarshan for broadcast/telecast right from the time when occurrence of cyclonic conditions is observed.

Flood warnings are provided by the Central Water Commission (CWC) of the Ministry of Water Resources through a network of 157 flood forecasting stations on various interstate rivers of the country. Warning time at the existing stations varies from Station to Station between 6 hours and 36 hours.

(b) Yes, Sir.

Meteorological Observational network, especially in the coastal areas, is being strengthened and the INSAT based Disaster Warning System (DWS) network available at present on Andhra Pradesh and Tamil Nadu Coasts, is being expanded.

Sinking of Sea Ward Defence Boat "INSDB-57" deployed in Palk Bay

- (a) whether a Sea Ward Defence Boat "INSDB-57" of the Indian Navy Coast Guard Force, deployed for patrolling on the Palk Bay sank sometime in December, 1990;

- (c) what action has been taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI LALIT VIJAY SINGH): (a) to (c) A Sea-Ward Defence Boat deployed for patrolling the Palk Bay had dragged her anchor and run aground on the night of 11th/12th December, 1990 due to rough weather. The boat was later hauled out and is presently berthed in Visakhapatnam. There were no casualties/injuries during this incident. A Board of Inquiry been instituted to assess the damage to the vessel and to establish causes of the incident. The report of of Inquiry is awaited, the Board
