SOURCE DEVELOPMENT (SHRI BHAGEY GOBARDHAN): (a) to (c) The news items in question did not come to the notice of the Government earlier because they were published in local newspapers. Such matters are considered by the Board of Governors of the Institute which is fully autonomous. However, the criminal case of alleged violation of Bihar Shops and Establishment Act by the Director of the Institute was brought to the notice of the Government This matter still being subjudice, question of instituting an enquiry by the Government does not arise.
